THE CENTER NOT ONLY PROVIDES A PLACE TO LIVE, BUT ALSO ASSISTS THEM WITH FREE IN-HOUSE EDUCATIONAL PROGRAMS, LEGAL ADVICE AND HEALTH CARE WHILE LIVING IN A LOVING AND CARING ENVIRONMENT. DURING THE YEAR, MAGIC MONGOLIA CENTER SERVES 60-70 CHILDREN DAILY, IN AVERAGE.
